Annual General Meeting [AGM] of the CBJEF

The 64th Annual General Meeting of The Canara Bank Jubilee Education Fund (CBJEF) was held at 3 P.M. on 24" September 2020 at Canara Bank's Staff Training College premises in Bangalore. The meeting had the participation of CBJEF's governing body as well as regular members. Shri H.M.Basavaraja, DGM, H R Wing, Canara Bank, H.O. and Hon. President - CBJEF took the chair and extended a cordial welcome. He thanked everybody for their presence and participation in the statutory meeting despite Covid -19 and its impact. Shri K.N.Chandrakanth Bhatt, AGM, F I Wing, Canara Bank H.O. & Hon. Secretary, CBJEF read out the Notice of the AGM. Presenting the highlights of the Annual Report for 2019-2020, Shri K.A.Bhat, Hon.Vice-President, CBJEF spoke about the unique "Text Book Bank" project, wherein sets of textbooks were provided to Pre-University students of government colleges at Lakkur (Kolar dist.), Hirisave (Hassan dist.) and Sirivanthe (Shimoga dist.) [lead districts of Canara Bank], during May-June 2019. Canara Bank which had always extended sustained support, had released Rs.five lakhs for the project. He also made a mention of other educational activities conducted during the year as well as the well organized "Pratibha Puraskara" programme conducted during September

CBJEF's Activities:

Enabling Education and Empowerment

"They are young men and women who carry a lamp within, which can be lit and made to glow...."

Education empowers an individual and enables a nation. It is the greatest sustaining factor in society's growth. However, a large segment of the younger generation still does not have access to schools and colleges, libraries and books because of various economic and social factors. Thus, especially in the new millennium, there has been a consolidation of educational reforms with specific policy initiatives for the girl-child. The recently announced new National Education Policy [NEP] also covers many related aspects right from foundational literacy and is expected to be truly transformative, based on the implementation process.

In addition to governmental efforts, individuals and institutions have also been supporting the cause of education in many ways. As part of this endeavour, for the past several years, the **CBJEF** has been organizing a function every year in association with **the Sanjivi Janardhan Kini Trust**, Bangalore (SJK Trust), wherein the Trust disburses prominent educational assistance directly to deserving needy students for their education. This year also, the SJK Trust provided educational assistance to the tune of Rs.3.10 lakhs to 45 needy students at different levels. However, due to Covid-19



The CBJEF's educational activities in Shimoga dist. (lead district of Canara Bank) - mainly in places like Sagar, Hosanagara, etc. are being conducted very successfully for over a decade. Shri Ma.Vem.Sa.Prasad, senior journalist, writer and social worker has been coordinating these programmes, which include 'Pratibha Puraskara' for SSLC students, Notebook distribution, Textbook Banks for P U students and so on. This time, in response to an appeal, the CBJEF made a contribution of Rs.10,000/for distribution of masks to SSLC students of Sagar and Hosanagara taluks. This covered part of the 2000 masks totally procured from Ambara Handicrafts & Garments, Sagar on June 23rd and handed over to K.R.Bimba, Sagar region education officer. Arrangements were made to distribute 1500 masks at Sagar and 500 masks to students at Hosanagara during the SSLC examination. While Shri Ma. Vem. Sa. Prasad facilitated the programme, Shri N.D.Hegde, journalist and coordinator of CBJEF's programmes at Hosanagara, played a key role in ensuring proper distribution of the masks [based on report] to students.
